**13. PERSONAL ACHIEVEMENT:** Finally, in addition to ensuring institutional growth, I have personally upgraded my professional qualifications by acquiring a PhD in ICT with focus on the application of ethics in ICTs, further strengthening my knowledge and expertise in leading ICTAZ towards excellence.

**14. ICTAZ MEMBERS IN CIVIL SERVICE:** In our endeavor to support our members in the civil service and enhance compliance levels, we successfully obtained authorization to facilitate the phased deduction of membership fees. This achievement was realized through effective leadership and collaboration with the eGovernment Division.

**15. COUNCIL WORKERS:** Leveraging the cooperation of Local Government authorities, we orchestrated the distribution of a directive to all local councils nationwide. This directive, with a deadline of March 1st, mandated the deduction of membership fees for ICT professionals employed within the councils.

**16. ENGAGEMENTS WITH THE MINES:** A landmark event in ICTAZ's history, we orchestrated a breakfast engagement meeting in Solwezi, attracting ICT professionals from major mining operations including Barrik, Mopani, Lumwana, Kansanshi, and KCM. This gathering was honored by the presence of the Permanent Secretaries of the Ministry of Technology and Science, alongside their counterparts from the North Western province.

**18. 2024 BUDGET ANALYSIS:** Demonstrating ICTAZ's commitment under my leadership, we organized a comprehensive post-2024 Budget analysis event graced by the Minister of Technology and Science, Honorable Felix Mutati.

**19. INTERNATIONAL EXPOS:** Building on past successes, we triumphantly hosted our annual international Exhibition for the second time. This event attracted participation from over 50 corporate entities, showcasing the vibrant ecosystem of the ICT sector.
